Notice is hereby given that a special town meeting of the Town of Milton, Buffalo County, Wisconsin will be held at the town hall located at S2794 State Rd 88, Fountain City, Wisconsin, on the 11th day of November, 2020, at 5:45 p.m. for the following purposes:

1. To consider the adoption of a resolution by the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under s. 66.0602, Wis. Stat., specifically a proposed tax levy which would exceed the allowable town tax levy for 2020, before adjustments, by 43 percent, for a dollar increase of \$25,000.
2. To approve the 2020 total town tax levy to be collected in 2021 pursuant to s. 60.10(1)(a), Wis. Stat.
